1.A Payment Policy

To ensure that your baby and your family are able to gain the most from being involved in the Bootkidz Program, families are required to attend a four week block or a 2 hour Superclinic which enable the full effect of the FITERACY framework to be experienced by your babies and family. The FITERACY framework involved events such as the dress up themes to IMMERSE children completely into the program and the concept of learning health, music and literacy.

A full deposit of a class fees is required 48 hours prior to class attendance and parents will be notified via sms or email of start times and class numbers prior to starting. Deposits and payments can be made via EFT using the details below:

4 week block= \$44 includes head bands and 20 minute solid work out for parents and other family or friend of family (adult role model in your babies life)

8 week term \$75

12 weeks \$120

Super clinic \$15 (1 hour)

\$22 (2 hour)

Casual visit following first 4 week block = \$15

All prices are inclusive of GST

Refund and Make Up Policy

At least 48 hours notice is required in order to have 4 week program fees refundable minus a \$15 administration fee

Once you have started your classes Bootkidz™ does not refund class payments however, it is very understandable that babies and parents get tired and sick and need to have a rest at times so we simply ask that you provide your coach notice so as we can notify your team of your absence and arrange your class to be placed in credit. Credits can only be held for the **following month** and must be used with payment of a 4 week block. Credited classes **can not** be used for casual visits. Eg if a class is missed in February, March payments will be credited 1 class.

Parents are asked to notify their Bootkidz Coach at least 2 hours prior to a class to be eligible to transfer their class to another makeup class or to be credited for the following month.

Please ask your Bootkidz coach where the nearest training in your area is or to have your missed class credited to a Super Clinic.

Be sure to ask your coach the best methods for notifying them of your inability to attend

Parent Involvement Policy

The Bootkidz program requires that all parents have a level of involvement in their child's program. Parents or carers attending a class will be required to CLAP, COUNT or COPY if attending a class so as to encourage children to be involved in activities also. Parents who are not feeling well or are feeling uncomfortable should still be able to CLAP or COUNT.
